Investment Summary

Granahan's Future Pathways Fund invests in 40-50 equities of small and mid cap ("SMID Cap") companies, focusing on traditional fundamentals while also uncovering the intrinsic value of societal impact. The goal of the strategy is intended to be flexible and adaptable to environmental and social issues as they arise, and able to rotate where the best opportunities exist for stock appreciation in this universe. The fund looks beyond ESG ratings data, instead focusing on the external benefit of the products and services provided by the holdings.  direct and impactful manner.







Monthly Commentary

We entered the month of April with the Federal Reserve wary of the elevated inflation numbers. This created concern that possibly there will be no cuts in interest rates in 2024, putting a damper on stocks. The Granahan Future Pathways UCITS Fund was down -8.7% (USD) versus the Russell 2500 Index down -7.5% (USD). Equally weighted HealthCare was the largest penalty to performance this month. Overweight Industrials and underweight Energy and Consumer Discretionary also suffered from poor stock selection. We are overweight Information Technology and Consumer Staples where our stock selection helped performance. Pioneers were the strength this month with Special Situations and Core Growth lagging. At month end, it was reported that the US added fewer jobs than expected in April but enough to indicate a still growing economy. For now, that could help keep a lid on inflation, prevent the Federal Reserve from needing to raise interest rates again and maybe even give them a reason to cut them later in the year.

The Russell 2500TM Growth Index measures the performance of the small to mid-cap growth segment of the US equity universe. It includes those Russell 2500 companies with relatively higher price-to-book ratios, higher *I/B/E/S* forecast medium term (2 year) growth and higher sales per share historical growth (5 years). The Russell 2500 Growth Index is constructed to provide a comprehensive and unbiased barometer of the small to midcap growth market. Future Pathways is a high conviction portfolio typically containing 40-50 holdings. The benchmark for Future Pathways strategy is the Russell 2500 Growth Index. The composite, created in September 2020, is calculated by asset-weighting the performance of each account on a monthly basis. Accounts are included beginning with the first full month under management and terminated accounts are included in the composite. Performance calculations, expressed in U.S. dollars, produce a total return including cash and the reinvestment of dividends and interest. The dispersion is a standard deviation using equal-weighted total returns for accounts in the composite the entire year. The three-year annualized standard deviation measures the variability of the composite and the benchmark returns over the preceding 36-month period. Leverage is not utilized. Policies for valuing portfolios, calculating performance, and preparing compliant presentations are available upon request. Returns are gross of investment management fees, which when included, reduce investment returns. The standard management fee applicable is applied to calculate the net return. The standard fee for accounts managed in the Future Pathways style is payable quarterly in arrears and is calculated by applying the ANNUAL rate of 1.00% times the average value of the assets in the account on the last day of each month in the quarter. Fees are collected quarterly, which produces a compounding effect on the total rate of return net of management fees. Market value is based on trade date and security pricing is supplied by Telemet.
